

MINUTES

ANNUAL GENERAL MEETING

1. Welcome

The President, Dr John Mark Simpson, welcomed all members to the 11th AGM of the veterinary profession in NSW. The meeting commenced at 7:40 pm.

4. President's Report

The President spoke to the review of the activities of the Board for the past financial year. The President called for questions and comments.

- i. The President proposed increases in a number of fees payable by veterinary practitioners and the addition of a late registration payment fee as outlined in this Report. Discussion was put to the meeting and none in attendance opposed.
- ii. The President proposed an increase in Board remuneration of 1.9% aligned with the weighted median annual CPI to June 2017. Discussion was put to the meeting and none in attendance opposed.

5. Audited Financial Statements

The President spoke to the audited financial statements and called for questions and comments. No questions or comments were received.

6. General Business

The President called for other questions and comments.

- There was some discussion regarding the role and value of the AVBC and the President noted
 that he was of the opinion the AVBC provide an excellent service for the profession ensuring
 consistency of decisions among Boards in relation to registration, the National Veterinary
 Exam, endorsement of specialists and accreditation of veterinary schools.
- 2. There was discussion regarding the Health Program and the value of other programs such as the AVA mentor program in addressing veterinarian health.
- 3. There was discussion regarding the possible role of the Board in relation to supporting new graduate veterinarians and it was noted that whilst the Board was limited by the legislation in what assistance it could provide the AVA mentor program was again considered to be a successful initiative in this area.
